Instructors Background:

Dr. Steven Regnier has a Doctorate in Organizational Leadership, is an alum of Calumet College and has recently retired as the Commanding Officer of Area South Property Crimes of the Chicago Police Department. He had worked for Chicago Police Department for 28+ years, and has taught at Calumet College since 2004. His police work included patrol and tactical, and he was promoted in March 2002 to the rank of Lieutenant. He is the past Vice President of the Chicago Police Lieutenants Association and is well versed in contract and labor issues. He also has been active in contract negotiations, and grievance proceedings.

Ray Schweitzer has a B.A & M.P.A. from Indiana University (NW). He has been an adjunct at Calumet College since 1984, also an adjunct at Trine University since 2006. Currently is a Detective Sergeant with the Munster Police Department, in Law Enforcement for 28+ years.

Course Description:

This course examines public safety management specifically at operational and administrative functions. Also collective bargaining and contractual issues will be reviewed.

Learning Outcomes/ Competencies:

- Students in this course will learn to apply critical thinking skills.
- Students will demonstrate an understanding of the elements that make up managerial decision-making.
- Students will learn about effective leadership practices.

Withdrawal from Classes Policy:
