Technology is integrated into each course throughout the program. The design of all courses requires Blackboard(Bb), so candidates engage in on-line experiences. Bb provides synchronous and asynchronous discussions, opportunities for reflections, assessments, postings, virtual chats, videos and web journal access.

Each classroom is a Smart Classroom equipped with Smart Board, projector, computer, digital document projector, video and television delivery capability. Each professor utilizes the technology and requires that the candidates do so also.

Candidates utilize e-textbooks to strengthen technology performance.

Student teachers utilize videos to evaluate teaching performance as well as electronic grading software and Excel for diagnostic assessment to analyze student assessment and make decisions to improve student learning.

Data on student performance are collected regularly for both individual and program assessment.
